Thank you for your letter dated April 11 to Secretary Clinton expressing the Chamber's views on whether the Alien Tort Statute grants United States courts jurisdiction to hear claims by foreign plaintiffs for damages for international law violations occurring within the territory of another country, and for the memorandum setting out legal arguments in support of your position. The Secretary has asked me to respond on her behalf.
