All:

As you might have already guessed, we fully intend to recover costs for personnel, supplies, and equipment associated with the Honeysuckle Lane incident on 06/30 (if we could figure out a way to charge for the aggravation this crap caused you, we'd do that, too). To do so, we need to accurately track those expenses.

On your time sheets (for the benefit of the newer officers), there are a couple of blanks just above the space for the supervisors' signatures, that are marked for "MVP Reg Hrs" and "MVP OT Hrs". After you have listed your total hours for 06/30 above on your time sheet (for C PLT officers who were working Tuesday night and got held over, you'll use 06/29), I need you to break those hours down to show:

- the number of hours assigned to the Honeysuckle incident while you were on regularly scheduled hours, if applicable; and/or,
- the number of hours assigned to the Honeysuckle incident while you were on overtime (anything other than your normal shift hours - meaning hours held over past the end of your shift, or called in early before your shift started, or called in on your day off)
- any hours you worked other than your normally scheduled hours will be repaid as OT (if you are considered non-exempt); we do not intend to ask you to reschedule time for this incident.

Several of you will have a combination of regular and OT hours, some just OT. We'll start tracking those hours when you turn in your times sheets.

Any purchases made to support this operation - food, water, saw blades, etc - need to be documented, as well. Please make sure, "MVP" or "Honeysuckle" or similar is written on the receipt so we'll know. Arlain, Megan, and Carol - if you get these receipts, please give Mia a heads up.

Be advised, we will similarly track expenses for any future pipeline-related incident.
