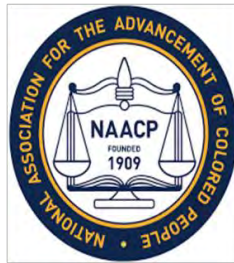

WATER AND SEWER INFRASTRUCTURE FUNDING PETITION

Dear Brunswick County Commissioners,

We, a group of Black residents residing in Brunswick County, submit this petition under Section 1-13-3 of the Brunswick County ordinances to improve access to clean water and proper sanitation services in Black communities located in unincorporated parts of the County. The signatories of this petition (“Petitioners”) are either community members who themselves do not have sufficient water and sewer services, or are community members who are in solidarity with those who do not. Even though the County ordinances states that the County will consider petitions for water and/or sewer extension if property owners either assume the costs or a satisfactory financial arrangement is available, we cannot afford to pay for water and sewer infrastructure improvement ourselves due to our financial circumstances.¹ Access to clean water and sanitation are basic human rights that we take seriously. We believe that it is unjust for our communities to be denied these rights because of socio-economic status or for the County to expect us to incur the costs of water and/or sewer extension. To remedy our concerns, we respectfully request that the Brunswick County Public Utilities Department and Brunswick County Environmental Health Department apply for a State Rural Grant and/or a Community Development Block Grant (“Block Grant”), and use the funds for the following:

- (1) for the extension water and sewer lines to the homes of disadvantaged residents, with simultaneous installation of new fire hydrants in the neighborhoods,
- (2) the hook up of water and sewer lines to the homes of disadvantaged residents, and
- (3) for private well retrofitting with up-to-date water filtration systems and piping for the homes of disadvantaged residents.

Although the Petitioners cannot afford the costs of water and/or sewer extension, there is unprecedented funding available that should be deemed as a satisfactory financial arrangement under Section 1-13-3. The Biden Administration has allocated a historic \$50 billion towards expanding water

infrastructure across the country over the next five years,² which includes increased funding of Block Grants. The Block Grants funding available for FY 2022-2023 has been increased to \$20 million in the State of North Carolina, and the Division of Water Infrastructure and State Water Infrastructure Authority have reported that millions in funds are still available for applications.³ The U.S. Department of Housing and Urban Development (HUD) has stated that municipalities and counties who administer water and sewer services, not just the State, are eligible to apply for these funds.⁴ Indeed, at least five North Carolina municipalities received Block Grants for improving water and sewer infrastructure from July 1, 2021- June 30, 2022, including Elizabeth City, Town of Woodland, Town of Enfield, Town of Benson, and the Town of Murphy.⁵

We reside in underserved areas in great need of improved infrastructure such as the connection and hook up to county water and sewer lines, access to fire hydrants, and resources for improving the quality of well water. The County has previously demonstrated its commitment to using grants to support low-income households in need of municipal water services. In 2010, the County received \$73,000 in Block Grant funds to connect twenty households to water lines.⁶ Further, the County publicly expressed its intention to assist low- and moderate-income homes with connections to public water lines. For example, the *CAMA Core Land Use Plan*, which was recertified in 2012, states, “Brunswick County and its participating municipalities will vigorously pursue grants to expand the water system for small and traditional communities.”⁷

Among the petitioners here who are in need of improved water infrastructure, our experiences with accessing clean water and sanitation services are varied. But an underlying issue that affects all of us is the fact that getting access to these much needed services is expensive and beyond our financial means. Some of the petitioners rely on private well water as their source of drinking water and septic tanks for their wastewater. Community members have complained of foul-smelling water and have expressed health concerns from relying on drinking water from private wells. These residents have stated that municipal well water testing services are too expensive to be economically feasible for routine checks on the quality of their well water. For some of these community members, water filtration systems to address water quality concerns are also economically out of reach and these residents have relied on buying bottled water. Municipal water and wastewater lines have not been extended to their neighborhoods and these residents cannot afford to pay the county fees to have the

municipal water lines extended as stipulated in county utility policies.⁸ Accordingly, we request that the County apply for Block Grant funding to extend municipal water and wastewater lines to our neighborhoods and pay for the hookup fees to residences. We are also concerned that the lack of water lines in our neighborhoods, and the resulting lack of fire hydrants, increases the risk to our homes and livelihoods in the case of fire, and request that the county apply for funding to install new fire hydrants simultaneously with new water and wastewater lines.

Other petitioners live in neighborhoods where municipal water and wastewater lines run along their street, but it is not economically feasible for us to connect to the municipal water lines given the high costs of hooking up under county utility rates.⁹ Because of these high costs, we request funding from the Block Grants to pay the fees associated with hooking up our homes to the municipal water lines in our neighborhoods.

Further, in support of the petitioners that exclusively rely on private wells, we request that the county apply for and allocate Block Grant funds to retrofit our wells with up-to-date water filtration systems and piping.

Scientific research on racial disparity in access to municipal water services in North Carolina bolsters our concerns with access to clean water. One 2014 study found that “every 10% increase in the African American population proportion within a census block increases the odds of exclusion from municipal water service by 3.8%.”¹⁰ The authors determined that “race is a significant predictor of water service access in census blocks within [unincorporated areas of a county] when controlling for property value and population density.”¹¹ In a 2020 study on the health impacts of private well water in North Carolina, the authors found that “children in homes relying on private wells have 25% increased odds . . . of elevated blood [lead], compared with children in houses served by a community water system.”¹²

Investing water infrastructure in underserved communities of Brunswick County is also important considering the risks from climate change. Climate change will further exacerbate water issues for Black residents across the state in coming years, including increased risk of flooding that can impact private water wells, risks of saltwater intrusion into underground aquifers that can both impact water quality and corrode aging lead pipes increasing health risks, and increasing risk of drought that can impact water systems.¹³

Our request for Block Grants would also help ensure that Brunswick County is meeting its civil rights obligations under the law. Brunswick County, as a recipient of federal funding, has a legal obligation under Title VI of the Civil Rights Act of 1964 to ensure that federal funds are distributed

and spent in a way that does not have an adverse disparate impact on racial minorities.¹⁴ If the County fails to uphold this obligation, it will be in violation of federal law.

Our proposal meets the intended purposes of Block Grant funds. The North Carolina Department of Commerce and North Carolina Department of Environmental Quality administer these public infrastructure funds to support the extension of water and sewer lines in rural communities or areas of low- and moderate-incomes, such as our neighborhoods.¹⁵ Administration of these funds to our neighborhoods also meets the HUD national objective of benefitting low- and moderate-income persons because it is an “activity which benefits all residents in a primarily residential area.”¹⁶ Further, the rate of illness related to the neighborhood reliance on well water is a public health crisis and requires urgent community development action. Finally, funding these infrastructure projects satisfies HUD’s requirement that 70% of funds go to low- and moderate-income residents over the period of funding.¹⁷

These grants would also meet the priority criteria of the State Water Infrastructure Authority, whose ranking system considers the financial situation of applicants through affordability criteria, including utility rates, population changes, poverty rate, median household income, unemployment, and property valuation per capita.¹⁸ The Authority compares these parameters to state benchmarks, and grants those applicants with criteria worse than state benchmarks higher priority than other applicants. Petitioners in need of water and sewer infrastructure meet these criteria.

Additionally, we believe that Brunswick County can obtain these funds. As a “non-entitlement community,” Brunswick County can request these funds from North Carolina; North Carolina is required to prioritize the communities with the most need, which we believe includes our communities. According to the North Carolina 2016-2020 Consolidated Plan, following a 2008 study to determine the state’s need for water and sewer improvements, the state began deploying the majority of its Block Grant funds to water and sewer grants.¹⁹ Since 2014, Brunswick County has been removed from this non-entitlement funding stream, allegedly due to lack of vocalized need for resources.²⁰ We disapprove this statement and are hereby vocalizing our need for these resources.

We also request a meeting with the County to further discuss our concerns and how to move forward with a Block Grant application. It is the responsibility of the state and local governments to
