I, Krystal Two Bulls, declare under penalty of perjury:

1. I currently reside in Billings, Montana. I have lived here since October of 2018, when I moved in with my partner and his two children.
2. My permanent residence is in Lame Deer, Montana, where I grew up, and where my parents still live. I have a P.O. Box there that I share with my parents. That address is P.O. Box 1138, Lame Deer, Montana, 59043. I have used this P.O. Box as my primary mailing address for over twenty years and my parents and I check it regularly. I have in the past received certified mail at that post box address.
3. I was living in Lame Deer with my parents from the summer of 2017 until I moved to Billings this October. Even after moving to Billings, I have visited Lame Deer every week, as I have to go to the high school there as part of college classes I am taking. Lame Deer is a small town of approximately 2000 people, and is located within the Northern Cheyenne Indian Reservation. Lame Deer is only about an hour and a half long drive from Billings.
4. I travel frequently for work, but I have certainly not made any attempts to evade service.

- In fact, when I moved in with my partner, I filed a notice of change of address with the post office, to ensure that I would receive mail sent to my P.O. box promptly, and I updated my credit cards and bank accounts. I wasn't making any effort to hide.
5. I have reviewed paragraphs 15-18 of Plaintiffs' declaration, Dkt. 115. I have never lived in the town of Colstrip, Montana, mentioned in that declaration. In fact, I have never even spent the night there. Colstrip is pretty close to Lame Deer, about 25 miles away, but outside of the reservation. I have traveled to Colstrip occasionally to attend cross-country meets for my siblings and some children I mentor. I also took my nephew there trick-or-treating on Halloween this year.
  6. I travel frequently for work and for pleasure. For example, from October 5-7, 2018, I was in Rapid City, South Dakota for the Crazy Horse Marathon. I was on a relay team and I stayed at the Comfort Inn. I used my own name to reserve the room. I was back at that same hotel for a full week later in October, after a relative of mine was hospitalized as a result of a severe assault. Again, I reserved the room under my own name. In November I traveled to Sand Creek, Colorado, for a memorial run commemorating the Sand Creek Massacre. I stayed at the Sheraton Downtown, from November 22-26, and again, I reserved the room under my own name. I also attended two Denver Broncos football games in Denver, in early September and late November 2018.
  7. I have been engaged in activism and organizing around environmental issues, indigenous people's rights, and veterans' issues for many years. I attended the Indigenous People's Power Projects National Action Camp Training from August 10-15 at the Woodbine Ecology Center in Denver, and the Black Hills Powwow from October 5-6 at the Civil Center in downtown Rapid City, South Dakota while I was there for the Crazy Horse Marathon. Obviously, I have not been hiding away since August. The effectiveness of

my work as an activist demands that it gain public attention.

8. I traveled to Phoenix on December 5 in order to attend the Veterans Organizing Institute. (I am a United States Army Veteran and served for 8 years, including a deployment to Kuwait from July 2009 through July 2010 as part of Operation Iraqi Freedom.) I noted in a public post on my Facebook page that I was traveling to Phoenix. It was on that trip that I was served. If anyone was actually looking to find me since August 2018, I am quite surprised that it took so long.
